AN ECONOMY THAT WORKS FOR ALL OF US

- **10.** What policies will you support to begin to address the systemic racial and economic inequality in Connecticut? (check all that apply)
 - □ Raising income and capital gains taxes on the top 3% of earners.
 - □ Forcing large low-wage employers to reimburse the state for poverty wage jobs.

Our state universities, healthcare agencies, and local governments struggle with diminishing state and federal funding at a time while the state continues to see historic savings. Will you work to loosen the restrictions these guardrails place on new spending?

- 13. The landmark 2019 to incrementally raise the minimum wage to \$15 an hour has given hundreds of thousands of CT workers a desperately needed raise. However, this law made no change to the tipped wages and some workers continue to make as little as \$6.38. Do you support legislation establishing one fair wage for all workers, with tips on top, so no employee makes a subminimum wage?

- 14. Throughout Connecticut, more than 350,000 low wage hourly shift workers, mostly people of color, in retail, food service and hospitality industries, many earning poverty wages, struggle to earn a stable income because of unpredictable and erratic work schedules. Recently proposed legislation would provide workers with two weeks advance notice of schedules, a rest period of 9-11 hours between shifts, some predictability pay for canceled shifts, first right of access to additional hours when they become available, and regulates practices like on-call scheduling that force workers to come in to work with no notice and lets workers refuse unscheduled hours without fear of retaliation. Would you support "fair workweek" legislation that provides workers more control over their schedules with predictable, stable hours and opportunity to work full time?

RACIAL JUSTICE
